# ASSIGNMENT OF SECURITY INTEREST

## (TRADEMARKS)

WHEREAS, Phillips-Van Heusen Corporation, a Delaware corporation (herein referred to as "Trademark Owner"), has adopted, used and is using the trademarks listed on the annexed Schedule 1 annexed hereto as part hereof, which trademarks are registered in the United States Patent and Trademark Office (the "Trademarks");

WHEREAS, Trademark Owner was obligated to The Chase Manhattan Bank (n/k/a JPMorgan Chase Bank), a New York banking corporation, as collateral agent (referred to herein as the "Grantor") and the other Secured Parties as defined in the Security Agreement dated as of April 22, 1998 (the "Original Security Agreement") among Trademark Owner, the other parties named therein and the Grantor for the payment and performance of the Obligations (as defined in the Original Security Agreement);

WHEREAS, pursuant to the Original Security Agreement, Trademark Owner granted to Grantor a security interest in, and mortgage on, all right, title and interest of Trademark Owner in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof (the "Collateral"), to secure the payment, performance and observance of the Obligations;

WHEREAS, Trademark Owner is now obligated to JPMorgan Chase Bank, a New York banking corporation, as administrative and collateral agent (referred to herein as the "Grantee") and the other Secured Parties as defined in the Omnibus Pledge and Security Agreement dated as of October 17, 2002 (the "Security Agreement") among Trademark Owner, the other Pledgors named therein and the Grantee for the payment and performance of the Secured Obligations (as defined in the Security Agreement); and

WHEREAS, pursuant to the Security Agreement, Trademark Owner has granted to Grantee a security interest in, and mortgage on, all right, title and interest of Trademark Owner in and to the Collateral, to secure the payment, performance and observance of the Secured Obligations;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Grantor assigns its security interest in, and mortgage on, all right, title and interest of Trademark Owner in and to the Collateral and Trademark Owner does hereby further grant to Grantee a security interest in, and mortgage on, the Collateral to secure the prompt payment, performance and observance of the Secured Obligations.

Trademark Owner does hereby further acknowledge and affirm that the rights and remedies of Grantee with respect to the assignment of, security interest in and mortgage on the Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.

Grantor does hereby confirm that its has relinquished all of its rights with respect to the Collateral.
