Please note that in response to a prior notice dated April 4, 1988, Consolidated Cigar Corporation had filed a request to have the change of name document already recorded at Reel 453, Frame 736-748, indexed against the above registration. A copy of such request, which had been mailed by certificate of mailing by the undersigned on May 4, 1988, is enclosed. Also enclosed is a copy of the aforementioned change of name document previously recorded in the Patent and Trademark Office. An examination of the change of name document discloses that while the document made appropriate reference to the BACKWOODS trademark on the third page of Schedule A (Frame 742), the registration number was recited incorrectly. The registration number recited, namely, Registration No. 958,870, was an obvious clerical repetition of the same registration number for the ANASTASIA trademark, which appeared two marks above the BACKWOODS entry.

Had the correct registration number been stated, namely, Registration No. 1,164,008, the assignment records of the office would have correctly reflected that Consolidated Cigar Corporation, the new name of Congar Manufacturing Company, Inc., was, in fact, the owner of record of the BACKWOODS registration.

Accordingly, it is respectfully submitted that the enclosed Amended Change of Name document be recorded against Registration No. 1,164,008 to correctly reflect that Congar Manufacturing Company, Inc. changed its name to Consolidated Cigar Corporation.
