In accordance with Section 16-10a-1006 of the Utah Revised Business Corporation Act ("URBCA"), Huntsman KCL Corporation, a Utah corporation (the "Corporation"), hereby declares and certifies as follows:

1. The name of the Corporation is Huntsman KCL Corporation.
2. Article I of the Articles of Incorporation of the Corporation (the "Articles") is hereby amended (the "Amendment") to delete Article I of the Articles in its entirety and to substitute the following provision:
