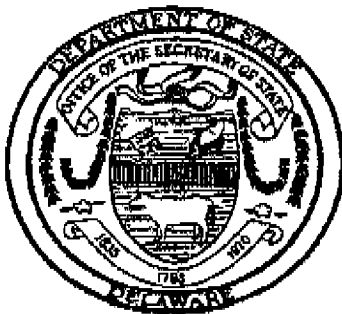

OF
CERTIFICATE OF INCORPORATION
OF
DEUTZ-ALLIS CORPORATION**

DEUTZ-ALLIS CORPORATION, a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (hereinafter called the "Corporation"), hereby certifies:

FIRST: That the Board of Directors of said corporation, at a meeting duly called and held on June 19, 1991, adopted a resolution proposing and declaring advisable the following amendment to the Certificate of Incorporation of said corporation:

"1. The name of the corporation is:

Gleaner-Allis Corporation."

SECOND: That in lieu of a meeting and vote of stockholders, the stockholders have given their unanimous written consent to said amendment in accordance with the provisions of Section 228 of the General Corporation Law of the State of Delaware.

THIRD: That the aforesaid amendment was duly adopted in accordance with the applicable provisions of Sections 242 and 228 of the General Corporation Law of the State of Delaware.
