## INTELLECTUAL PROPERTY SECURITY AGREEMENT SUPPLEMENT

This INTELLECTUAL PROPERTY SECURITY AGREEMENT SUPPLEMENT (this "*IP Security Agreement Supplement*") dated October 9, 2002, is made by the parties listed on the signature page hereof (collectively, the "*Grantors*" and each a "*Grantor*") in favor of Bank of America, N.A., a national banking association, in its capacity as administrative agent (the "*Administrative Agent*") for the Lenders (as defined in the Credit Agreement referred to below).

WHEREAS, Home Interiors & Gifts, Inc., a Texas corporation, has entered into an Amended and Restated Credit Agreement dated as of June 30, 2001 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*Credit Agreement*"), with Bank of America, N.A., as Administrative Agent, and the Lenders party thereto. Terms defined in the Credit Agreement and not otherwise defined herein are used herein as defined in the Credit Agreement.

WHEREAS, pursuant to the Credit Agreement, each Grantor has executed and delivered that certain Amended and Restated Security Agreement dated June 30, 2001 to the Administrative Agent (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*Security Agreement*") and that certain Amended and Restated Intellectual Property Security Agreement dated June 30, 2001 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*IP Security Agreement*").

WHEREAS, under the terms of the IP Security Agreement, each Grantor has granted to the Administrative Agent, for the ratable benefit of the Secured Parties (as defined in the IP Security Agreement), a security interest in the Additional Collateral (as defined in Section 2 below) of each Grantor and has agreed as a condition thereof to execute this IP Security Agreement Supplement for recording with the U.S. Patent and Trademark Office, the United States Copyright Office and other governmental authorities.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor agrees as follows:

SECTION 1. Grant of Security. Each Grantor hereby grants to the Administrative Agent, for the ratable benefit of the Secured Parties (as defined in the IP Security Agreement), a security interest in all of such Grantor's right, title and interest in and to the following (the "*Collateral*"):

- (i) the patents and patent applications set forth in Schedule A hereto (the "*Patents*");
- (ii) the trade names, trademarks and service marks, and the applications for registration of trade names, trademarks and service marks set forth in Schedule B hereto, together with the goodwill of the businesses connected

with the use of (or associated with) such trade names, trademarks and service marks, and symbolized thereby (the “**Trademarks**”);

(iii) the copyrights, copyright registrations and applications for such registrations set forth in Schedule C hereto (the “**Copyrights**”);

(iv) all continuations, renewals, extensions, damages and payments now or hereafter due and payable under and with respect to any of the foregoing;

(v) all claims, without limitation, for damages for past, present or future infringements to any of the foregoing, and the right to sue for past, present and future infringements to any of the foregoing; and

(vi) all proceeds and products of the foregoing.

SECTION 2. Supplement to IP Security Agreement. The Annexes to the IP Security Agreement are, effective as of the date hereof, hereby supplemented to add to such Annexes the Collateral as described in Schedules A, B, and C attached hereto (such Schedules A, B, and C, collectively, the “**Additional Collateral**”).

SECTION 3. Security for Obligations. The grant of a security interest in the Additional Collateral by each Grantor under this IP Security Agreement Supplement secures the payment of all Obligations of each Grantor now or hereafter existing under or in respect of the Loan Documents, whether direct or indirect, absolute or contingent, and whether for principal, reimbursement obligations, interest, premiums, penalties, fees, indemnifications, contract causes of action, costs, expenses or otherwise.

SECTION 4. Recordation. Each Grantor authorizes and requests that the Register of Copyrights, the Commissioner for Patents and the Commissioner for Trademarks and any other applicable government officer to record this IP Security Agreement Supplement.


SECTION 5. Grants, Rights and Remedies. This IP Security Agreement Supplement has been entered into in conjunction with the provisions of the IP Security Agreement. Each Grantor does hereby acknowledge and confirm that the grant of the security interest hereunder to, and the rights and remedies of, the Administrative Agent with respect to the Additional Collateral are more fully set forth in the IP Security Agreement, the terms and provisions of which are incorporated herein by reference as if fully set forth herein.

SECTION 6. Governing Law. This IP Security Agreement Supplement shall be governed by, and construed in accordance with, the laws of the State of Texas.


