RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Trademark Security Interest Release is granted and conveyed by Lehman Commercial Paper Inc., having its principal business at 745 Seventh Avenue, New York, New York 10022 ("LCPI"), in favor of Distinctive Dining, Inc., having its principal business address at 1460 Buffet Way, Eagan, Minnesota 55121 ("Distinctive Dining").


WHEREAS, LCPI and Distinctive Dining entered into an Intellectual Property Security Agreement dated as of September 29, 2000 (the "Security Agreement"), under which Distinctive Dining granted to LCPI a security interest in the trademark applications and trademark registrations listed on the attached Schedule A, and the goodwill associated therewith (the "Marks").

WHEREAS, the United States Patent and Trademark Office ("PTO") recorded the Security Agreement on October 13, 2000 against the Marks at Trademark Reel 002172, Frame 0727;

WHEREAS, Distinctive Dining has satisfied all of its outstanding obligations under the Amended and Restated Security Agreement, and the parties seek to make a record of LCPI's release and reassignment to Distinctive Dining of any and all of its security interest in the Marks.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, LCPI hereby (1) releases, discharges and relinquishes its security interest in the Marks, and (2) reassigns to Distinctive Dining all right, title and interest that LCPI may have had in the Marks including the goodwill associated with the Marks. LCPI specifically acknowledges that the Security Agreement is no longer effective, and that LCPI does not own any rights to or have any ownership interest in the Marks.


