TRADEMARK ASSIGNMENT

Assignor represents and warrants that it will cooperate in any actions necessary for Assignee to prosecute, renew, file, or register its rights, title, and interests in and to the Mark, including United States and foreign applications and registrations, and to cooperate in any actions brought to enforce the rights accompanying this Assignment against third parties.

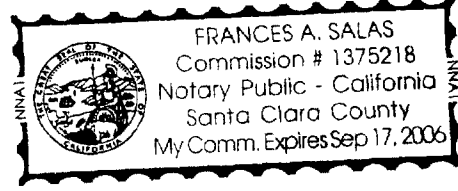
