THIS RELEASE AND REASSIGNMENT is executed as of October 8, 2002 by **TRANSAMERICA TECHNOLOGY FINANCE CORPORATION** successor in interest to **TRANSAMERICA BUSINESS CREDIT CORPORATION**, a Delaware corporation ("TransAmerica").

WITNESSETH:

WHEREAS, TransAmerica, and Cielo Communications, Inc., a Delaware corporation ("Grantor"), are parties to that certain Loan and Security Agreement (as amended, restated, supplemented, or otherwise modified from time to time, the "Loan Agreement") pursuant to which Grantor incurred certain liabilities to and granted a security interest in and collateral assignment of certain intellectual property identified in the Loan Agreement as security for Grantor's obligations to TransAmerica;

WHEREAS, TransAmerica and Grantor are parties to a certain Patent and Trademark Security Agreement, dated as of November 25, 1998 (the "Security Agreement") pursuant to which Grantor incurred certain liabilities to and granted a security interest in and collateral assignment of the "Collateral" (as defined in the Security Agreement), including, without limitation, the trademark registrations and applications for trademark registration issued thereon or applied for in the United States or throughout the world, including registrations, recordings, supplemental registrations and pending applications for registration in the United States Patent and Trademark Office (collectively, the "Registrations") as described in Schedule A attached hereto, as security for Grantor's obligations to TransAmerica under the Security Agreement;

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on December 14, 1998, on Reel 1830, Frame 0897; and


