**EXPLANATION OF CHAIN OF TITLE**

This document is being recorded in order to explain and clarify the chain of title regarding the above-captioned trademark registration. The chain of title for this trademark registration has been as follows:

1. The registration was initially issued to the Prudential Insurance Company of America on October 12, 1993.
2. The Prudential Insurance Company of America assigned the registration to Norwest Mortgage, Inc. on May 7, 1996. This Assignment is recorded at Reel/Frame 2535/0555.
3. Norwest Mortgage, Inc. executed a Certificate of Amendment on March 29, 2000, changing its name to Wells Fargo Home Mortgage, Inc. as of April 14, 2000. This change of name is recorded at Reel/Frame 2534/0644.

There have been additional documents recorded regarding this trademark registration, which should not be considered as affecting the chain of title. The Assignment recorded at Reel/Frame 1695/0546 has an incorrect cover sheet, which incorrectly lists Norwest Corporation, rather than Norwest Mortgage, Inc., as the assignee of the registration.


The merger and change of name recorded at Reel/Frame 2129/0270 should not be considered as affecting the chain of title, because it incorrectly relied on the erroneous cover sheet associated with Reel/Frame 1695/0546.

Similarly, the purported Assignment from Wells Fargo & Company to Wells Fargo Home Mortgage, Inc. recorded at Reel/Frame 2129/0226 is without affect because the registration was not owned by Wells Fargo & Company at the time of the purported assignment.

In summary, the Assignment recorded at Reel/Frame 2535/0555 and the change of name recorded at Reel/Frame 2534/0644 evidence the correct chain of title for the "JUST SAY YES" trademark registration. The other recorded documents regarding this trademark registration are without effect.
