ASSIGNMENT

WHEREAS, Pursuant to the merger of Ecutel PCS, LLC, a Tennessee limited liability company ("Original Owner"), into Ecutel, PCS, LLC a Virginia limited liability company ("Assignor") (formerly known as Ecutel Acquisition, LLC) on June 24, 1998, Assignor acquired all right, title and interest in and to the assets and business of Original Owner, including all right, title and interest in and to the mark(s) listed in Exhibit A attached hereto, for which Original Owner filed applications for registration in the Patent and Trademark Office.

WHEREAS, effective December 31, 1999 Assignor's certificate of organization was automatically cancelled for failure to pay fees.

WHEREAS, under Section 13.1-1064 (D) of the Virginia Limited Liability Company Act a limited liability company's certificate of organization cannot be reinstated more than two years after cancellation.

WHEREAS, under Section 13.1-1046 of the Virginia Limited Liability Company Act, a limited liability company whose certificate of organization is automatically cancelled for failure to pay fees is deemed to be dissolved.

WHEREAS, under Section 13.1-1048 of the Virginia Limited Liability Company Act and Section 7.3(c) of the Assignor's Operating Agreement, the members of a dissolved limited liability company have the authority to wind up the limited liability company's affairs.

WHEREAS, Ecutel, Inc. ("Assignee"), a Delaware corporation, having an address of 4401 Ford Avenue, Alexandria, Virginia 22303, is the sole member of Assignor, and in connection with the winding up of Assignor's affairs, acquired all of the assets of Assignor, including all right, title and interest in and to said marks, the applications and/or registrations

thereof, together with the goodwill of the business associated with the marks and the assets associated with the marks as of December 31, 1999.

WHEREAS, the parties desire to ratify said assignment;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby assign to Assignee all right, title and interest in and to said marks and the applications and/or registrations thereof, together with the goodwill of the business symbolized by the marks, nunc pro tunc as of December 31, 1999.
