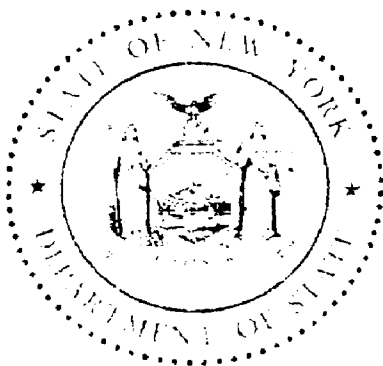

**ARTICLES OF ORGANIZATION
of
COMMUNITY PRODUCTS, LLC**

Under Section 203 of the Limited Liability Company Law

FIRST: The name of the limited liability company is Community Products, LLC (the "Company").

SECOND: The nature of the business or purposes to be conducted or promoted is to engage in any lawful act or activity for which limited liability companies may be organized under the Limited Liability Company Law. The Company is not formed to engage in any act or activity requiring the consent or approval of any state official, department, board, agency, or other body without such consent or approval first being obtained.

THIRD: The county within the State of New York in which the principal office of the Company will be located is Ulster County.

FOURTH: The latest date on which the limited liability company is to dissolve is December 31, 2095, unless a majority of the members consent to the continuation of the Company for a specified period prior to such date.

FIFTH: The Secretary of State is designated as the agent of the Company upon whom process against it may be served. The post office address within or without this state to which the Secretary of State shall mail a copy of any process served upon it is Community Products, LLC, Route 213, Box 903, Rifton, NY 12471.

SIXTH: The name and street address within the State of New York of the registered agent of the Company upon whom and at which process against the Company can be served is c/o Herzog, Engstrom & Koplovitz, PC, 99 Pine Street, Albany, NY 12207.


SEVENTH: The Articles of Organization shall be effective upon filing with the Department of State.

EIGHTH: The Company is to be managed by its members.

NINTH: The Company shall have the power to indemnify, to the fullest extent permitted by the Limited Liability Company law of this state, as amended from time to time, all persons whom it is permitted to indemnify.

TENTH: These Articles of Organization and the Operating Agreement may be amended in any and all respects upon the approval of a majority of the members notwithstanding the restrictions stated in Section 417(b) of the Limited Liability Law of this state.

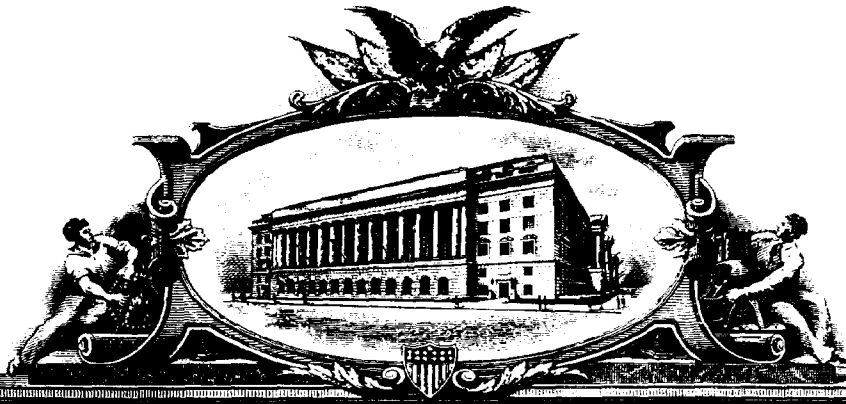

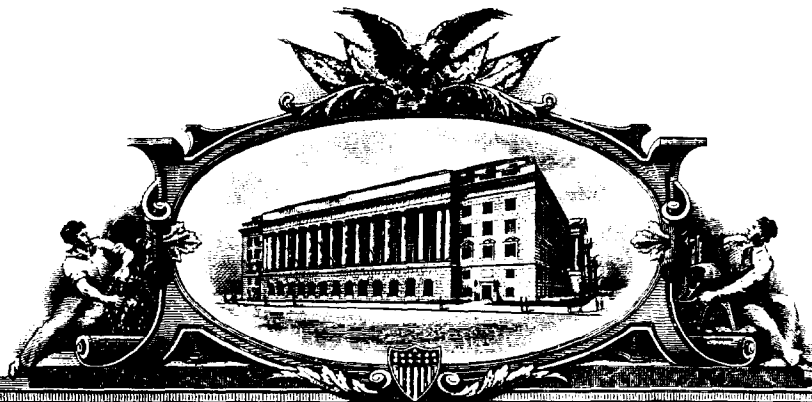

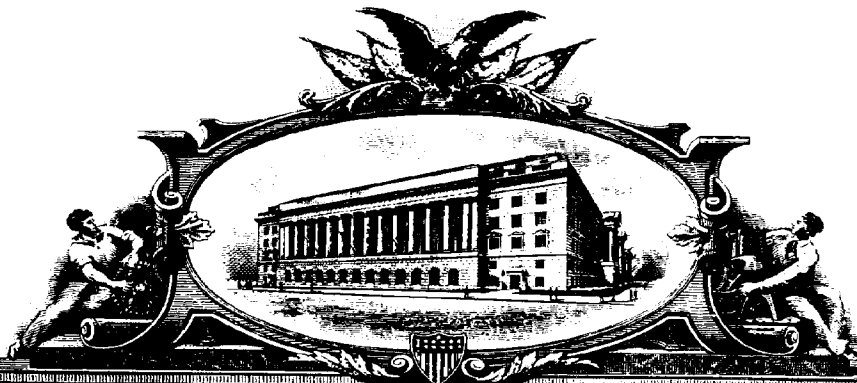
