

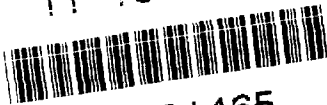

TRADEMARK ASSIGNMENT


