TRADEMARK ASSIGNMENT

WHEREAS, ALLTRISTA PLASTICS CORPORATION, a Indiana corporation, hereinafter referred to as Assignor, having its principal office and place of business at 5875 Castle Creek Pkwy, Suite 440, Indianapolis, Indiana, has agreed to transfer its entire right, title, and interest in and to the United States trademarks listed on the attached Exhibit A (“Trademark Rights”) pursuant to that certain Asset Purchase Agreement (the “Purchase Agreement”) dated as of October 15, 2001 by and between Assignor and Wilbert, Inc., an Illinois corporation, hereinafter referred to as Assignee.

NOW, THEREFORE, for and in view of the consideration exchanged in the Asset Purchase Agreement, receipt of which is hereby acknowledged, Assignor hereby sells, assigns, transfers, and sets over unto Assignee, its successors and assigns, its entire right, title, and interest in and to the Trademark and Service Mark Rights, together with that portion of the good will of the business of Assignor connected with the use of and symbolized by the trademarks and service marks included in the Trademark Rights and the know how associated with and necessary to control the nature and quality of the goods and services associated with the Trademark Rights, and all causes of action, past, present, and future for infringement of the Trademark Rights.

Upon request, Assignor agrees to promptly execute and deliver any and all additional and further instruments as may be necessary to effect, record, and implement this Assignment.

Assignor further covenants and agrees that it will, at any time upon request and at Assignee’s expense, execute and deliver any and all documents that may be necessary or

desirable to perfect the title to the Trademark Rights in Assignee, its successors, and assigns and that it will, at any time upon request, communicate to Assignee, its successors, and assigns such facts relating to the Trademark and Service Mark Rights or the history thereof as may be known to it.


