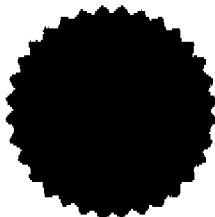

**AMENDED AND RESTATED  
 CERTIFICATE OF LIMITED PARTNERSHIP  
 OF  
 WEATHERFORD GLOBAL COMPRESSION SERVICES, L.P.**

The undersigned, desiring to amend and restate the Certificate of Limited Partnership of Weatherford Global Compression Services, L.P. pursuant to the provisions of Section 17-210 of the Revised Uniform Limited Partnership Act of the State of Delaware (the "LP Act"), does hereby certify as follows:

**FIRST:** The name of the limited partnership is Weatherford Global Compression Services, L.P. (the "Partnership"). The Partnership was originally formed under the same name, and the original Certificate of Limited Partnership of the Partnership was filed with the Secretary of State of the State of Delaware on February 2, 1999.

**SECOND:** Pursuant to Section 17-210 of the LP Act, this Amended and Restated Certificate of Limited Partnership restates and integrates and also further amends the provisions of the Certificate of Limited Partnership. The text of the Certificate of Limited Partnership is amended and restated in its entirety as follows:


**FIRST:** The name of the limited partnership is Universal Compression Services, L.P. (hereinafter referred to as the "Partnership").

**SECOND:** The address of the registered office of the Partnership in the State of Delaware is Corporation Trust Center, 1209 Orange Street, in the City of Wilmington, County of New Castle, Delaware 19801. The name of the registered agent of the Partnership at that address is The Corporation Trust Company."

**THIRD:** The name and mailing address of the sole general partner is Weatherford Global Compression Holding, L.L.C., 1231 Greenway Drive, Suite 550, Irving, Texas 75038.

IN WITNESS WHEREOF, the undersigned, as sole General Partner of the Partnership, has executed this Amended and Restated Certificate of Limited Partnership on this 7<sup>th</sup> day of March, 2001.
