**SHORT FORM SECURITY AGREEMENT
(Grantor)**

This SHORT FORM SECURITY AGREEMENT is made as of February 24, 2003, by V. W. Eimicke Associates, Inc., a New York corporation, with its chief executive office at 35 East Grassy Sprain Road, Yonkers, New York 10710 ("Grantor"), in favor of Taylor Corporation, a Minnesota corporation, with an office at 1750 Tower Boulevard, North Mankato, Minnesota 56003 ("Lender").

RECITALS

A. The Grantor has entered into a Security Agreement in favor of Lender dated February 24, 2003 (the "Security Agreement").

B. In order to perfect Lender's interest the assets in accordance with the Security Agreement, Grantor has executed this Short Form Security Agreement for recordation with the appropriate state and federal governmental authorities.

NOW, THEREFORE, for good and valuable consideration the receipt and adequacy of which are hereby acknowledged by each of the parties hereto, it is agreed as follows:

1. All defined terms in this Short Form Security Agreement have the meaning ascribed to them in the Security Agreement and all terms of the Security Agreement remain in full force and effect.

2. As security for the payment of all Obligations, Grantor hereby grants to Lender a security interest in all of Grantor's right, title and interest in and to all the property listed in the Security Agreement, including but not limited to the Trademarks set forth on Exhibit A attached hereto and the Copyrights set forth on Exhibit B attached hereto.
