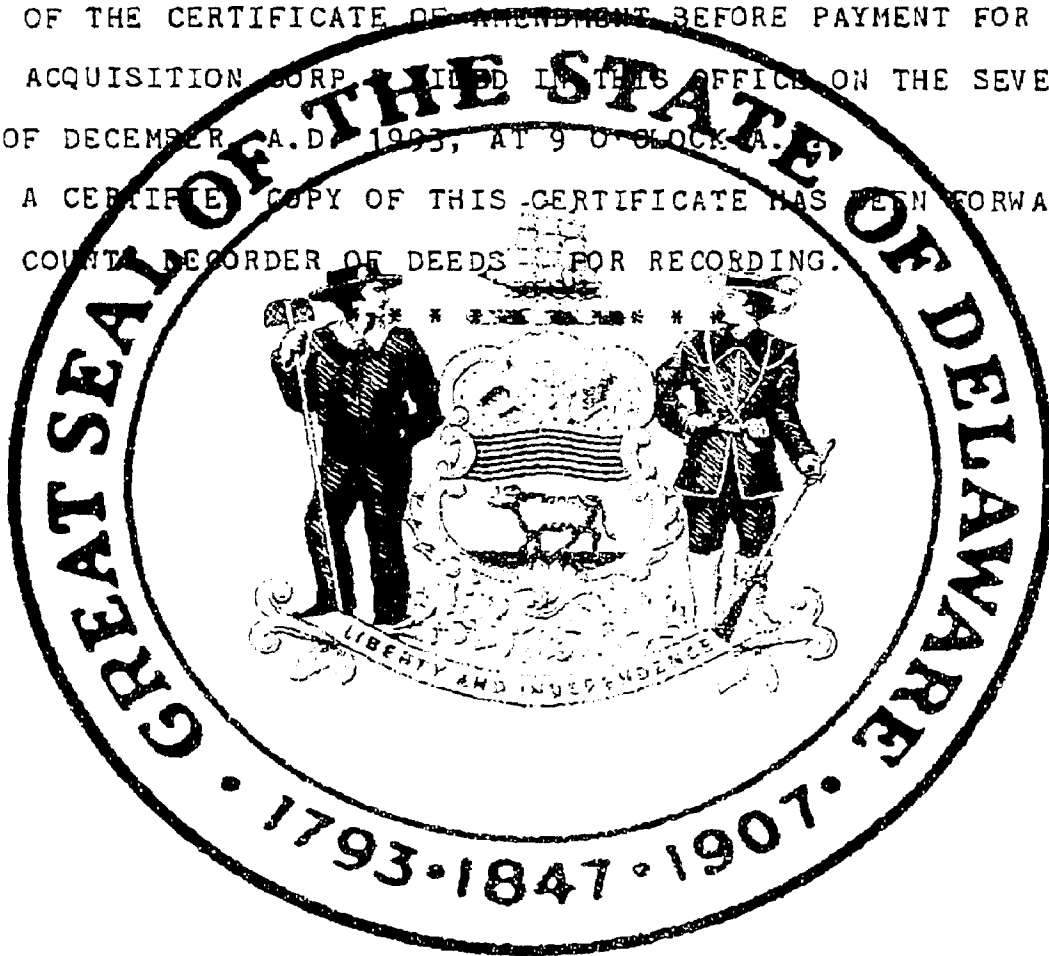

FIRST: That the Article of the Certificate of Incorporation of said corporation numbered "FIRST" is hereby amended to read in its entirety as follows:

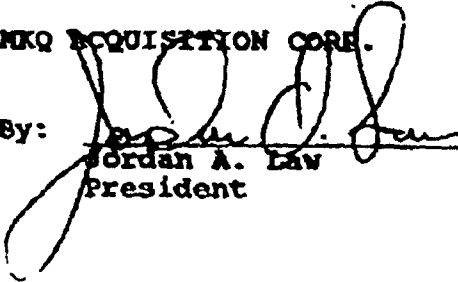
"The name of the corporation is Kaynar Technologies Inc. (the "Corporation")."

SECOND: That the corporation has not received any payment for any of its stock.

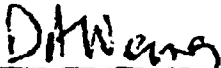
