ASSIGNMENT OF TRADEMARK

WHEREAS, Assignor, Adams USA Athletics, Inc., and Assignee wish to confirm ownership by Assignee of legal title to the Mark;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Bolco Athletic Co., Inc. hereby assigns *nunc pro tunc* to Adams USA Athletics, Inc. all right, title and interest in and to the Mark, together with the goodwill of the business symbolized by the Mark, and Adams USA Athletics, Inc. hereby assigns *nunc pro tunc* to Adams USA, Inc. all right, title and interest in and to the Mark, together with the goodwill of the business symbolized by the Mark..
