ASSIGNMENT

This Assignment is made as of the 10th day of February 2003, by and between Intersystems Corporation, having a place of business at One Memorial Drive, Cambridge, Massachusetts 02142 ("Intersystems"), and, State Street Bank and Trust Company, having a place of business at 225 Franklin Street, Boston, MA 02210, ("SSBTC").

WHEREAS, pursuant to a Collateral Assignment of Trademarks dated June 17, 1998, and recorded on June 26, 1998, at Reel 1749, Frame 0015, SSBTC acquired from Intersystems the entire right, title and interest in and to the trademark applications, registrations, and trademarks and associated goodwill as listed in the attached Schedule A of Trademarks (hereinafter "Trademarks");

WHEREAS, SSBTC desires to assign back to Intersystems, and Intersystems desires to reacquire all right, title and interest in and to the Trademarks, including the goodwill represented by the Trademarks.

NOW, THEREFORE, for one Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency which are hereby acknowledged:

1. SSBTC hereby assigns to Intersystems all of SSBTC's worldwide right, title and interest in and to the U.S. and foreign Trademarks and the registrations and applications therefor as set forth in the attached Schedule A of Trademarks, together with the goodwill of the business symbolized thereby.

2. Intersystems hereby acknowledges and consents to this Assignment by SSBTC to Intersystems of all of SSBTC's right, title and interest in and the Trademarks and all registrations and applications therefor, together with the goodwill of the business symbolized by said Trademark and the applications and registrations therefor.

3. SSBTC hereby grants to Intersystems the right to sue and recover damages for past, present and future infringement of the Trademarks and any registrations therefor. SSBTC further agrees to execute all documents, and do such other acts, as may be deemed reasonably necessary by Intersystems to record or perfect assignment of the Trademarks to Intersystems.

4. This Trademark Assignment may be executed in one or more counterparts, each of which shall be deemed to be an original, but all of which shall be one and the same document. A copy or facsimile of a signature shall be binding upon the signatory as if it were an original signature.

5. This Trademark Assignment shall be governed by and construed in accordance with the laws of the Commonwealth of Massachusetts.

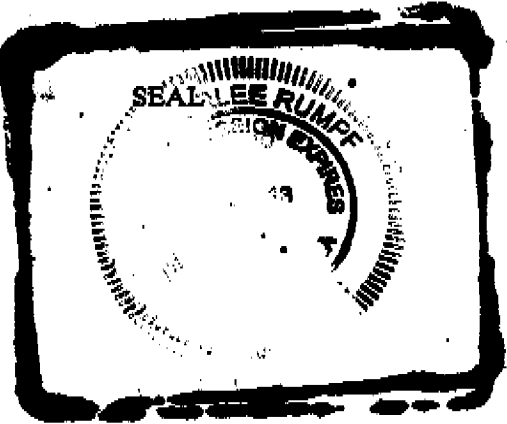
