

WHEREAS, Envopak Group Limited (hereinafter, "Seller") having Company Number 596706 whose registered office is at PO Box 87, Queensway, Fforestfach, Swansea, SA5 4YE, United Kingdom has adopted, used and is using the trademarks identified on Exhibit A attached hereto;

WHEREAS, ITW Limited (hereinafter, "Buyer") having Company Number 55969 whose registered office is at PO Box 87, Queensway, Fforestfach, Swansea, SA5 4YE, United Kingdom purchased certain assets from Seller pursuant to an Agreement dated 2 December 2002 (with effective date 1 December 2002);

WHEREAS, said assets purchased by Buyer includes the aforementioned trademarks, as well as the goodwill of the business associated therewith;

WHEREAS, pursuant to the Agreement, Seller agrees to assign its interests in said trademarks and the goodwill of the business associated therewith over to Buyer;

NOW, THEREFORE, in consideration of and in exchange for the sum of \$1.00 and other good and valuable consideration, the receipt of which is hereby acknowledged, Seller does hereby sell, assign, transfer and set over to Buyer the entire right, title and interest in and to said trademarks, the registrations referred to above, and all other related registrations or applications in all countries, including the rights to sue for past infringements, and the goodwill of the business associated with said trademarks;

AND HEREBY AGREES upon request of Buyer, its successors, assigns or legal representatives, and without further remuneration, to execute any and all papers, or documents desired by Buyer, its successors, assigns or legal representatives, to fulfil the intent and purposes of this Assignment;

AND HEREBY COVENANTS that no assignment, sale or encumbrance has been or will be made or entered into which would conflict with this Assignment.

AND HEREBY AGREES that this Assignment may be executed in any number of counterparts, each of which shall be deemed to be an original and which shall together constitute one and the same assignment.

AND HEREBY AGREES that no term of this Assignment shall be enforceable under the Contracts (Rights of Third Parties) Act 1999 by a person who is not a party to this Assignment.

AND HEREBY AGREES this Assignment shall be governed by the Laws of England in every particular including formation and interpretation and shall be deemed to have been made in England and both parties agree to submit to the exclusive jurisdiction of the courts of England.




