ASSIGNMENT OF TRADEMARKS

This Assignment of Trademarks (this "*Assignment*") is made this 23rd day of October, 2002, by and between Clearwater, Inc., a Pennsylvania corporation, Transit Energy Systems, Inc., a Delaware corporation, Clearwater Specialty Chemical Company, a Nova Scotia company, PriTech International, Inc., a Texas corporation, CWI International, Inc., a Delaware corporation, and Clearwater International, L.L.C., a Delaware limited liability company.

WHEREAS, Clearwater, Inc., Transit Energy Systems, Inc., Clearwater Specialty Chemical Company, Pritech International, Inc., and CWI International, Inc. (individually and collectively referred to as "CLEARWATER") is the sole and exclusive owner of all rights, title and interest in and to the trademarks, service marks, and any and all applications therefor listed on the attached Appendix A ("Trademark Assets"); and

WHEREAS, Clearwater International, L.L.C., 515 Post Oak Blvd., Suite 600, Houston, Texas, 77027, USA, hereinafter referred to as "ASSIGNEE", is desirous of acquiring all rights, title and interest in the Trademark Assets.

NOW, THEREFORE, for and in consideration of One Dollar (\$1.00) and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by CLEARWATER, CLEARWATER has assigned, sold, transferred and set over and by these presents does hereby assign, sell, transfer and set over unto said ASSIGNEE the all rights, title and interest in and to said Trademark Assets, including but not limited to: (a) all world-wide rights therein, (b) all goodwill associated therewith, and (c) all United States and foreign trademarks which shall issue on any pending trademark applications forming part of Trademark Assets,, the same to be held and enjoyed by said ASSIGNEE, its assigns and successors, as fully and entirely as the same would have been held and enjoyed by CLEARWATER, had this Assignment and sale not been made.

CLEARWATER covenants and agrees that it will, at any time upon the request and at the expense of said ASSIGNEE, execute and deliver any and all papers and to all lawful acts that may be necessary or desirable, in the opinion of said ASSIGNEE, to enable and assist said ASSIGNEE (a) obtain trademark registrations, both domestic and foreign, as part of Trademark Assets, (b) establish, maintain and secure title in said ASSIGNEE, its successors and assigns to said Trademark Assets, including making such title of lawful public record, and (c) defend, establish or otherwise preserve the validity of said Trademark Assets against any and all infringers, and perform such other acts are necessary to give full force and effect to this Assignment.

CLEARWATER hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States and the respective Trademark Offices around the world to issue all trademark registrations forming part of and arising out of trademark applications forming part of Trademark Assets to said ASSIGNEE, its successors and assigns.

This Assignment may be executed in any number of counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
