RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE (TRADEMARK) is given as of this 15th day of March 2003 by Heller Financial, Inc., a Delaware corporation located at 500 W. Monroe Street, Chicago, Illinois, 60661 ("Assignor"), to Air-Serv Group, LLC (f/k/a Air-Serv Operations, LLC), a Delaware limited liability company located at 1370 Mendota Heights Road, Mendota Heights, Minnesota, 55120 ("Assignee"), as follows:

WHEREAS, Assignor and Assignee entered into a Collateral Assignment and Trademark Security Agreement, dated as of July 8, 1998 (the "Security Agreement"), which was recorded in the United States Patent and Trademark Office on July 24, 1998 at Reel 1730, Frame 0559, pursuant to which Assignee granted to Assignor a security interest in and made a collateral assignment of all of Assignee's right, title and interest in and to the Trademark Rights (as defined in the Security Agreement) referred to in Exhibit A thereto, and identified in Schedule 1 to this RELEASE, and all good will associated with the Trademark Rights, to induce Assignor to consummate the financial accommodations to Assignee provided for in the Credit Agreement (as referenced in the Security Agreement); and

WHEREAS, Assignee has promptly paid and performed all its Obligations under the Security Agreement and Assignor desires to release its security interests in and liens upon the Trademark Rights.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby releases its lien on and security interest in all Assignee's right, title and interest in and to the Trademark Rights and reassigns any and all interest it may have in such Trademark Rights to Assignee.
