RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (the "Release") is entered into as of this 14th day of November, 2002, by and between BANK OF AMERICA, N.A., with a place of business at 600 Peachtree Street, 5th Floor, Atlanta, Georgia 30308, as agent (the "Agent") for certain Lenders (as defined below) and DIAGNOSTIC IMAGING, INC., with a place of business at 4345 Southport Boulevard, Jacksonville, Florida 32216 (the "Obligor").

WITNESSETH:

WHEREAS, the Agent, the Lenders (as defined in the Credit Agreement, defined below), the Obligor and certain other entities are parties to that certain Credit Agreement, dated as of May 24, 2001, as amended, modified, confirmed or supplemented to the date hereof (the "Credit Agreement");

WHEREAS, the Obligor has granted a security interest to the Agent in certain trademarks and service marks owned by the Obligor (the "Trademarks") pursuant to the Credit Agreement and a Conditional Assignment and Trademark Security Agreement, dated as of May 24, 2001, by and among the Obligor, certain other obligors and the Agent (the "Trademark Security Agreement");

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office (the "PTO") on July 13, 2001, at Reel 2332, Frame 0466, to evidence the security interest granted to the Agent;

WHEREAS the Obligor has requested that the Agent: (a) terminate and release the liens and interests of the Agent in the Trademarks; and (b) execute and deliver evidence of such termination and release for filing in the PTO; and

WHEREAS the Agent has agreed to such termination and release pursuant to and subject to a letter agreement, dated as of October 24, 2002 (the "Letter Agreement"), by and among the Obligor, certain other obligors, the Agent, and the Lenders.

NOW, THEREFORE, in consideration of the Letter Agreement and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby acknowledges and agrees as follows:

Acknowledgment of Termination of Grant of Security Interest in Trademarks. All rights and security interests of the Agent in and to the Trademarks, as set forth in Schedule A attached hereto and incorporated herein by reference, have been terminated and released and are no longer in force.
