At any time after the date of this Assignment, Assignor hereby agrees that Assignor shall deliver and shall cause its affiliates and related parties to, from time, to time, execute and deliver to Assignee such additional instruments, documents, conveyances, or assurances and take such other action as shall be necessary, or otherwise reasonably be requested by Assignee, to confirm and assure the rights and obligations provided for in this Assignment and render effect the consummation of the transactions contemplated hereby, or otherwise to carry out the intent and purposes of this Assignment.

This Assignment shall be governed by, and construed in accordance with, the laws of the United States, in respect to trademark issues and in all other respects including as to validity, interpretation and effect, by the laws of the State of New York, without giving effect to the conflict of laws rules thereof.


