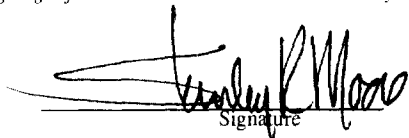

The undersigned corporations, CHAUVIN INTERNATIONAL, LTD., a California corporation ("Chauvin"), and B.U.M. INTERNATIONAL, INC., a Nevada corporation ("B.U.M."), do hereby certify:

1. Chauvin is a corporation duly organized and validly existing under the laws of the State of California.
2. B.U.M. is a corporation duly organized and validly existing under the laws of the State of Nevada.
3. B.U.M. will be the surviving corporation.
4. The Articles of Incorporation of B.U.M. as existing prior to the effective date of the merger, shall continue in full force as the Articles of Incorporation of the surviving corporation.
5. The complete executed Merger Agreement dated August 12, 1994 ("Merger Agreement") which sets forth the plan of merger providing for the merger of Chauvin into B.U.M. is on file at the corporate offices of B.U.M..
6. A copy of the Merger Agreement will be furnished by B.U.M. on request and without cost to any stockholder of any corporation which is a party to the merger.
7. The plan of merger as set forth in the Merger Agreement has been approved by Unanimous Written Consent of the Board of Directors of Chauvin dated August 12, 1994.
8. The plan of merger as set forth in the Merger Agreement has been approved by Written Consent of the sole shareholder of Chauvin dated August 12, 1994. Chauvin has 427.5 shares of common stock issued, outstanding and entitled to vote on the plan of merger of which all 427.5 shares voted in favor of the merger.

9. The plan of merger as set forth in the Merger Agreement has been approved by Joint Unanimous Written Consent of the Board of Directors and Sole Stockholder of B.U.M. dated August 12, 1994. B.U.M. has 1,000 shares of common stock issued, outstanding and entitled to vote on the plan of merger of which all 1,000 shares voted in favor of the merger.

10. The manner in which the exchange of issued shares of Chauvin shall be affected is set forth in the Merger Agreement.

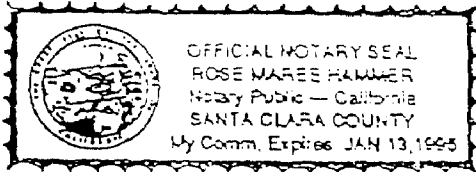

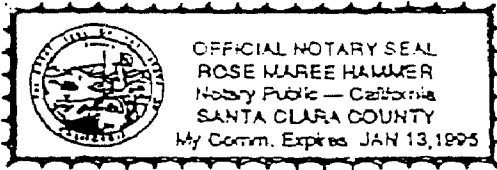
