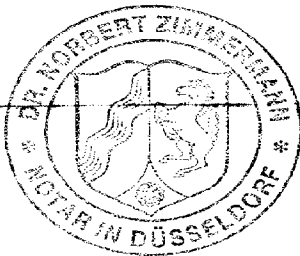

The merger became effective upon its registration in the aforementioned register of Commerce on February 9, 2001. Thus, all assets and liabilities of Degussa-Hüls Aktiengesellschaft and SKW Trostberg AG passed into the ownership of Degussa AG.
