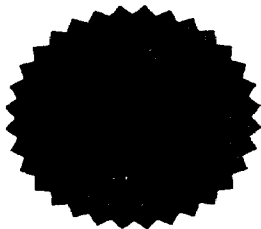

**RESTATED CERTIFICATE OF INCORPORATION**

CONAM INSPECTION, INC., a corporation organized and existing under and by virtue of the  
General Corporation Law of the State of Delaware,

DOES HEREBY CERTIFY:

FIRST: That the Board of Directors of said corporation, by unanimous written consent of its  
members, filed with the minutes of the Board, adopted a resolution proposing and declaring  
advisable the following amendment to the Restated Certificate of Incorporation of said  
corporation:

RESOLVED, that the Restated Certificate of Incorporation of CONAM INSPECTION,  
INC. be amended by changing the FIRST Article thereof so that, as amended, said Article shall  
be read as follows:


"The name of the corporation is STAVELEY SERVICES NORTH AMERICA, INC."

SECOND: That in lieu of a meeting and vote of stockholders, the stockholders have given  
unanimous written consent to said amendment in accordance with the provisions of Section 228  
of the General Corporation Law of the State of Delaware.
