ASSIGNMENT OF TRADEMARK RIGHTS

This Assignment of Trademark Rights (this "Assignment") is entered into effective November 25, 2002 by International Paper Company, a New York corporation ("Assignor"), and International Paper Trademark Company, a Delaware Corporation ("Assignee").

Background

1. Assignor owns 100% of all issued and outstanding stock of Assignee.
2. Assignor is an operating company in the paper products and distribution business. Assignor operates various business units and is continuously developing new product lines, new logos, new trademarks and other aspects of marketing and sales of products and services.
3. Assignee has been formed and operates as a special purpose trademark protection company, with principal purposes including, among others, the following:
 - Title to US trademarks
 - Protection of trademarks
 - Exploitation of trademarks
 - Protection against infringement by use of trademarks
 - Investment and cash management
4. Assignor has developed the trademarks identified in Schedule A ("Trademarks") and intends by this Assignment to contribute and assign all right, title and interest in and to the Trademarks, including all rights of registration, to Assignee, pursuant to the provisions of Section 351 of the Internal Revenue Code of 1986, as amended.

Agreement

Now therefore, the parties agree as follows:


