DELNI ZGODOVINSKI IZPISEK IZ SODNEGA REGISTRA

Podjetje ELAN, tovarna športnega orodja je bilo v registru podjetij in obrtov vpisano do 23. 9. 1974, ko se je konstituiralo v DO s firmo: ELAN, tovarna športnega orodja Begunje na Gorenjskem, n.sol.o., v sestavi katere je bilo konstituiranih 6 temeljnih organizacij združenega dela.

Zaradi preoblikovanja v enovito DO dne 31. 1. 1986 je bila spremenjena firma v ELAN, tovarna športnega orodja, p.o., temeljne organizacije združenega dela pa so postale sestavni del enovite DO.

Dne 19. 10. 1990 je bil nad to DO uveden stečajni postopek, zaradi česar je bila ponovno spremenjena firma v ELAN, tovarna športnega orodja Begunje, p.o. – v stečaju.

Dne 12. 12. 1991 je bila vpisana zaznamba prodaje stečajnega dolžnika kot pravne osebe, stečajni postopek pa se je nad stečajnim dolžnikom ustavil, nadaljeval pa se je proti stečajni masi.

Dne 31. 3. 1992 je bila vpisana sprememba firme kupljene pravne osebe v ELAN, podjetje za ustanavljanje, financiranje in upravljanje z drugimi podjetji, d.d., Begunje, Begunje na Gorenjskem.

Dne 27. 6. 2000 je družba prenesla sedež v Ljubljano, Dunajska cesta 160 in bila vpisana sprememba firme v ELAN, družba za ustanavljanje, financiranje in upravljanje z drugimi družbami, d.d., Begunje 1, Begunje na Gorenjskem.

Dne 12. 12. 2001 je bila vpisana sprememba firme v ELAN, proizvodnja izdelkov za šport in prosti čas, d.d., in sedeža v Begunje 1, Begunje na Gorenjskem, na katerem družba posluje.

Ostali podatki so kot nepotrebni izpuščeni.

Taksa v znesku 680 SIT uničena na zaprosilu.

## PARTIAL HISTORICAL EXTRACT FROM THE COURT REGISTER

The enterprise *ELAN, tovarna športnega orodja* had been entered onto the Register of Enterprises and Plants until September 23, 1974 when it was constituted as a working organization with the following name: *ELAN, tovarna športnega orodja Begunje na Gorenjskem, n.sol.o.* which was comprised of 6 basic organizations of associated labour.

As a result of its being transformed, on January 31, 1986, into a uniform working organization, the firm's name was changed to read *ELAN, tovarna športnega orodja, p.o.*, while the basic organizations of associated labour became part of the uniform working organization.

As a result of initiating, on October 19, 1990, a bankruptcy proceeding, the firm's name was changed to read *ELAN, tovarna športnega orodja Begunje, p.o. - v stečajju.*

Entered onto the Court Register on December 12, 1991 was the selling of the debtor in bankruptcy as a legal person, the bankruptcy proceeding relating to the debtor in bankruptcy was terminated but it was continued with respect to the bankrupt's estate.

Entered onto the Court Register on March 31, 1992 was a change of name of the purchased legal person into *ELAN, podjetje za ustanavljanje, financiranje in upravljanje z drugimi podjetji, d.d.*, Begunje, Begunje na Gorenjskem.

On June 27, 2000 the firm transferred its seat to Ljubljana, Dunajska cesta 160, and a further change of name was entered, namely, *ELAN, družba za ustanavljanje, financiranje in upravljanje z drugimi družbami, d.d.*, Begunje 1, Begunje na Gorenjskem.

Entered on December 12, 2001 was a change of the firm's name to *ELAN, proizvodnja izdelkov za šport in prosti čas, d.d.*, and a change of its seat to Begunje 1, Begunje na Gorenjskem where the firm has been doing business.

All other data are irrelevant and therefore omitted.

The tax of SIT 680,00 has been defaced in the request.
