Pursuant to KRS 275.360, the undersigned limited liability company executes the following Articles of Merger:

A. The name and jurisdiction of formation of each constituent business entity which is to merge are Lee Brick Company, LLC, a Kentucky limited liability company, and Lee Masonry Products, Inc., a Kentucky corporation.

B. The Plan of Merger is as follows:

(1) The name of the constituent business entities which shall be a party to the merger are Lee Masonry Products, Inc. and Lee Brick Company, LLC; the name of the surviving business entity shall be Lee Masonry Products, LLC.

(2) The terms and conditions of the proposed merger are that the Shareholders of Lee Masonry Products, Inc. shall receive one Share of the surviving business entity, Lee Masonry Products, LLC, for each Share owned of Lee Masonry Products, Inc. Limited liability shall be retained by the surviving business entity, Lee Masonry Products, LLC.

(3) The manner of converting Interests in Lee Masonry Products, Inc. into Interests in Lee Masonry Products, LLC shall be that the owner of each Share in Lee Masonry Products, Inc. shall own an equal number of Shares in Lee Masonry Products, LLC.

(4) No other changes to the Articles of Organization of Lee Brick Company, LLC or of Lee Masonry Products, Inc. are desired to be effected by the merger.

C. The name of the surviving business entity shall be Lee Masonry Products, LLC.

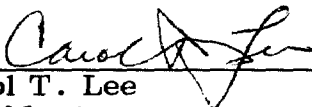
D. The Plan of Merger was duly authorized and approved by each constituent business entity in accordance with KRS 275.350. The Plan of Merger was

approved by unanimous consent of the Members of Lee Brick Company, LLC. The Plan of Merger was approved by the unanimous consent of the Shareholders of Lee Masonry Products, Inc. The number of votes entitled to be cast was 100. The number of votes cast for the Plan of Merger was 100; no votes were cast against the merger. The merger shall take effect upon March 30, 1999.

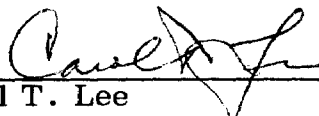
