- 1. That by Unanimous Consent of the Board of Directors dated April 26, 2001, a resolution was passed declaring that the following change and amendment in the Articles of Incorporation is advisable:

WHEREAS, Article One of the Articles of Incorporation states "The name of this Corporation is PES Incorporated".

IT IS THEREFORE RESOLVED, that said Article One of the Articles of Incorporation be amended to read: "The name of this Corporation is WellDynamics Inc." and further

RESOLVED, that said amendment is advisable and the consent of the stockholder of this Corporation was called to take action on the foregoing resolution.

- 2. That pursuant thereto, by written consent dated April 26, 2001, the Corporation's stockholder, being the sole holder of all of the Corporation's 200,000 shares of issued stock, representing 100% of the voting power and entitled to vote on the adoption of said amendment, voted to amend the Articles of Incorporation so that the same shall read as follows and so that the following amended article shall in all respects take the place of the original Article One of the Articles of Incorporation of this Corporation and any and all amendments thereto:


