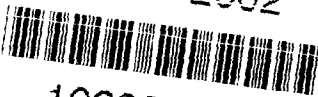


RELEASE OF SECURITY INTEREST

WHEREAS, The ScientificWorld, Inc., a corporation organized and existing under the laws of the State of Florida, having a principal place of business at 1903 S.
