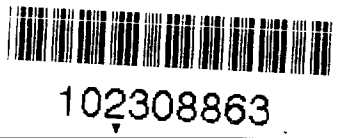

SERVICE MARK ASSIGNMENT



ASSIGNOR hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States of America in which Service mark application is pending, to record the title of ASSIGNEE, its successors, legal representatives and assigns, as owner of all right, title and interest in and to the Service mark, together with the good will of the business associated with and symbolized by the Service mark, and to issue the Certificate of Registration resulting from the application for the Service mark to ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

This Assignment is effective as of the date hereof. ASSIGNOR agrees that it will execute and deliver, or cause to be executed and delivered, to ASSIGNEE or ASSIGNEE's legal representatives, any other or additional assignments, powers and other appropriate documentation, and take all additional actions, necessary to effectuate, validate and record this Assignment with the United States Patent and Trademark Office in which the Service mark application is pending, under the relevant laws of the United States set forth in Schedule A, as soon as is practicable after the date of this Assignment.


