

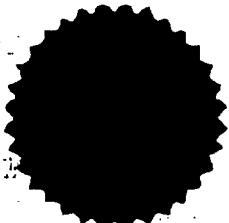

"First. The name of the corporation (hereinafter called the "corporation" is:


PROQUEST BUSINESS SOLUTIONS INC."


