
CONFIRMATORY U.S. TRADEMARK ASSIGNMENT

WHEREAS, Guard-Line, Inc., a Texas corporation having its principal place of business at P.O. Box 1030, Atlanta, Texas ("Guard-Line") has entered into a settlement agreement with World Triathlon Corporation, a Florida corporation having its principal place of business at 43309 U.S. Highway 19N, Tarpon Springs, Florida ("WTC") in which Guard-Line has agreed to assign its rights to the trademark IRONMAN GUARD LINE identified in U.S. Trademark Application Serial No. 75/853,339 (the "Trademark") and WTC has agreed to acquire the entire right, title and interest in and to the Trademark, including all goodwill associated therewith, and;
