ASSIGNMENT OF TRADEMARKS

4. This Assignment shall be binding upon the parties, their successors, heirs, assigns, legal representatives and all others acting by, through, with or under their direction, and all those in privity therewith.
5. Assignee shall record this Assignment of Trademarks with the United States Patent and Trademark Office.
