Except to the extent that federal law preempts state law with respect to the matters covered hereby, this Assignment of Trademarks shall be governed by and construed in accordance with the laws of the State of Ohio without giving effect to the principles of conflicts of laws thereof. The parties agree that any dispute, action, suit or proceeding at law, in equity or otherwise which in any way arises out of or relates to this instrument shall be filed in any state court located in Cuyahoga County, Ohio or in the United States Federal District Court for the Northern District of Ohio.



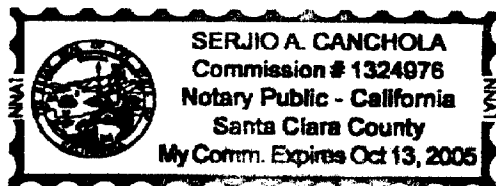


