

### **CORRECTION OF ASSIGNMENT RECORDAL**

Sirs:

The owner of the above registration has been made aware of discrepancy in the chain of title of the registration.

In a refusal of a combined Sections 8&15 Affidavit, the Post-Registration Examiner determined that this registration issued to Lepage's **Incorporated, a Pennsylvania Corporation**. The Office records do not show the registration being transferred from this entity to Lepage's **Inc., a Delaware Corporation**. LePage's Inc. assigned the mark to our client, U.S. Tape and Sticky Products LLC.

U.S. Tape and Sticky Products, LLC (hereinafter U.S. Tape)

1

purchased the registrations shown in the Assignment from LePage's and the assignment document was prepared and executed by LePage's. In our request to record the assignment, submitted to the Office on March 18, 2002, we advised the Office that LePage's had registered a number of marks under a variety of names, namely - LePage's, Inc.; LePage's, Incorporated; LePage's Incorporated and LePage's Acquisition Corp. At the time, we believed that LePage's, Inc. was the correct corporate name but did not realize that the State of Incorporation was Pennsylvania and not Delaware as set out in the assignment.

After the refusal of an 8&15 Affidavit for registration number 1,971,643, the Owner's attorneys conducted a search of the Pennsylvania Department of State's records. It was determined that:

- 1. LePage's was, in fact, incorporated in Pennsylvania.
- LePage's was incorporated under the name LePage's, Inc. not
   LePage's Incorporated.
- 3. It was also determined that LePage's, Inc. has been withdrawn from the Pennsylvania Department of State's records because it has ceased to operate.

A copy of the online search of the Pennsylvania Department of State's website is attached hereto. These documents confirm the above facts.

U.S. Tape, through their attorneys, contacted LePage's former counsel in an attempt to locate an officer of LePage's in order to obtain a corrected assignment. The former counsel is not aware of the location of any of the former officers of LePage's. He did confirm, however, that LePage's, Inc. has ceased to operate. U.S. Tape is therefore unable to obtain a corrected

assignment for recordal with the U.S. Patent and Trademark Office.

U.S. Tape respectfully submits that it was LePage's intention to transfer the patents and trademarks listed in the Assignment to U.S. Tape and Sticky Products, LLC.

U.S. Tape therefore requests that the Office:

Correct the Office Records to show that the owner of the various registrations shown in the attached assignment was LePage's, Inc., a Pennsylvania corporation and not LePage's, Inc. a Delaware corporation; LePage's, Incorporated; LePage's Incorporated or LePage's Acquisition Corp.

**LePage's, Inc.** is confirmed to be the correct legal name of the company by the records from the Pennsylvania Department of State and these records further confirm that LePage's, Inc. was incorporated in Pennsylvania.

Correct the assignment from LePages, Inc., a Delaware corporation, recorded on 03/20/02, reel 002471, frame 0185 by changing the State of Incorporation of LePages, Inc. from Delaware to Pennsylvania.

To effect these corrections, the Owner encloses a new Recordation Form Cover Sheet and the required fee. A copy of the originally submitted Cover Sheet is enclosed herewith for review by the Office.
