## GENERAL INTELLECTUAL PROPERTY ASSIGNMENT

Pursuant to the Purchase Agreement, as amended, by and among The Procter & Gamble Company, an Ohio corporation ("P&G"), and the Individual Members of Dr. Johns Products, Ltd, an Ohio limited liability company ("Company") relating to Sellers' Dr. Johns SpinBrush business and dated December 12, 2000 (the "Purchase Agreement"), and the closing of the transaction on January 5, 2001, P&G acquired 100% of the ownership units of the Company and thereby acquired 100% of the assets and liabilities of the Company except as stated otherwise in the Purchase Agreement.
