

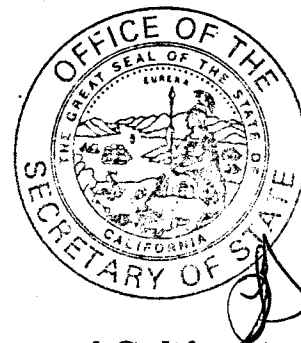

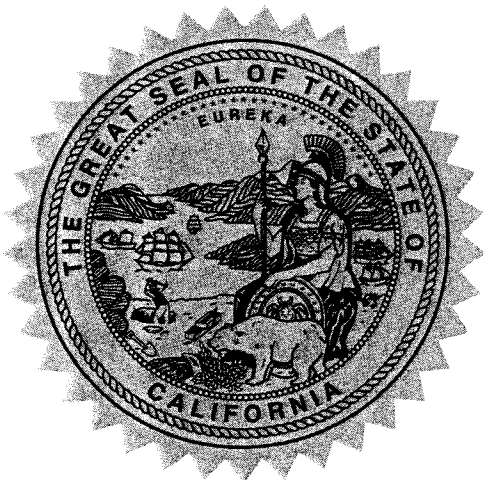

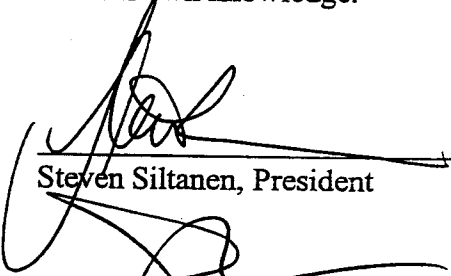
Steve Siltanen and Bruce Pincus certify that:

1. They are the President and Secretary, respectively, of Watergate Software, Inc., a California.
2. Article ONE of the Articles of Incorporation of this corporation is amended to read as follows:

"ONE: The name of the corporation is PC-Doctor, Inc."
3. The foregoing amendment of the Articles of Incorporation has been duly approved by the Board of Directors.
4. The foregoing amendment of Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 902 of the Corporations Code. The corporation has only one class of shares and the number of outstanding shares is 120,000,000. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than 50%.

We further declare under penalty of perjury under the laws of the State of California that the matters set forth in this certificate are true and correct of our own knowledge.
