2. ASSIGNOR hereby consents to ASSIGNEE being entered on the Register of Trademarks of the country or countries corresponding to the registrations appearing on the attached Schedule as the subsequent proprietor of the TRADEMARKS.
3. To the extent necessary, ASSIGNOR will provide whatever cooperation and documentation are necessary, at the request and expense of ASSIGNEE, to allow ASSIGNEE to record

its interest in and to the TRADEMARKS in the country or countries corresponding to the registrations appearing on the attached Schedule.
