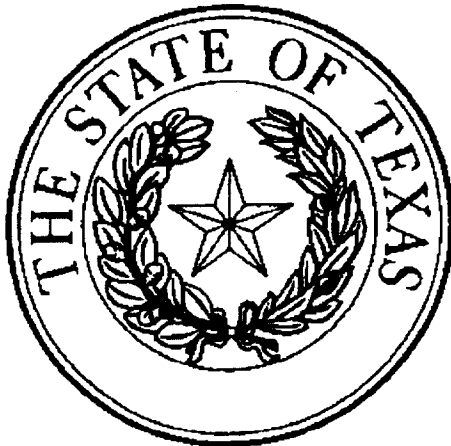

Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, the undersigned corporation adopts the following articles of amendment to its articles of incorporation:

1. The name of the corporation is **Emergency Services Consultants, Inc.**
2. The following amendment to the articles of incorporation was adopted by the shareholders of the corporation on September 25, 2001:
