**TRADEMARK SECURITY AGREEMENT**

WHEREAS, Medex, Inc., an Ohio corporation, located at 6250 Shier Rings Road, Dublin, Ohio 43016 ("MI"), has adopted, used and is using the marks shown in the attached Schedule A (the "Marks"), for which there are registrations or applications in the United States Patent and Trademark Office under the numbers shown in the attached Schedule A; and

WHEREAS, MI is obligated to The Huntington National Bank, a national banking association, as Administrative Agent for and on behalf of the lenders (the "Lenders") from time to time party to the Credit Agreement (as defined herein) pursuant to (i) a certain Revolving Credit and Term Loan Agreement, dated the date hereof, among Administrative Agent, the Lenders, MI and the other Credit Parties (as defined therein) (the "Credit Agreement") and (ii) a certain Trademark Collateral Security Agreement, dated the date hereof, made by MI in favor of the Administrative Agent, for and on behalf of the Lenders (as each may be amended, modified, restated or supplemented from time to time, collectively, the "Agreements"); and

WHEREAS, pursuant to the Agreements, MI is granting to the Administrative Agent, for and on behalf of the Lenders, a security interest in the Marks, the goodwill of the business symbolized by the Marks, and the registrations and applications therefor.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, MI does hereby collaterally assign unto the Administrative Agent and grants to the Administrative Agent, for and on behalf of the Lenders, a security interest in and to the Marks, together with the goodwill of the business symbolized by the Marks, and registrations and applications therefor, which security interest shall secure all the Secured Obligations as defined in the Agreements and in accordance with the terms and provisions thereof.

MI expressly acknowledges and affirms that the rights and remedies of the Administrative Agent with respect to the security interest granted hereby are more fully set forth in the Agreements.


