ASSIGNMENT

For good and valuable consideration, RioPort, Inc., a Delaware corporation ("Assignor"), hereby assigns, transfers, and conveys to SONICblue Incorporated., a Delaware corporation ("Assignee"), all of Assignor's right, title and interest throughout the world in and to the trademarks listed in Schedule 1 of that certain Trademark Assignment and License Agreement dated as of the second day of May 2002 between Assignee and Assignor and any and all other marks using the term "Rio" not therein listed together with the goodwill associated therewith ("the Marks") and the United States Trademark Registration Numbers and Serial Numbers as listed in such Schedule 1 in International Class and any other pending foreign trademark applications or registrations for the Marks, as of the execution date of this assignment.

Furthermore, Assignor conveys to Assignee the right to sue, or defend, or bring or maintain other actions to protect the interests in the Marks, including without limitation oppositions and actions for past, present, and future infringement. Assignor agrees to take such further action and to execute such documents as Assignee may reasonably request to effect or confirm the conveyance to Assignee of the Marks. Assignor hereby irrevocably designates and appoints the Assignee and its duly authorized officers and agents, as Assignor's agents and attorneys-in-fact to act for and in behalf and instead of Assignor, to execute and file any documents and to do all other lawfully permitted acts to further the above purposes with the same legal force and effect as if executed by Assignor.

This Agreement may be amended or modified only by a written instrument executed by all of the parties hereto.
