**TERMINATION AND RELEASE  
OF  
SECURITY INTEREST IN PATENTS AND TRADEMARKS**

This Termination and Release of Security Interest in Patents and Trademarks (hereinafter, the "Termination and Release") is executed by Comerica Bank - California ("Secured Party"), in favor of Sagent Technology, Inc., a Delaware corporation ("Debtor").

**RECITALS**

A. Debtor and the Secured Party entered into a certain Intellectual Property Security Agreement, dated as of October 5, 2001 (as amended, modified or supplemented from time to time, the "Security Agreement"), in connection with the Loan and Security Agreement, dated as of October 5, 2001, by and between the Debtor and the Secured Party (as amended, modified or supplemented from time to time, the "Loan Agreement").

B. Pursuant to the Security Agreement, Debtor granted to the Secured Party a security interest in certain intellectual property.

C. The Security Agreement was filed with a Recordation Form Cover Sheet with the Patent and Trademark Office (i) in the case of Patents on November 15, 2001 with Reel and Frame Number: 012312/0510; and (ii) in the case of Trademarks on November 16, 2001 with Reel and Frame Number: 2396/257.

D. Debtor has paid all amounts owing under the Loan Agreement and has met all other obligations related thereto.


The Secured Party therefore expressly terminates and releases its security interest in the Intellectual Property Collateral, including without limitation, the patents and patent applications listed on Schedule A hereto and the trademarks and trademark applications listed on Schedule B hereto.

Unless otherwise defined herein, all other capitalized terms used herein and defined in this Termination and Release shall have the respective meanings given to those terms in the Security Agreement.
