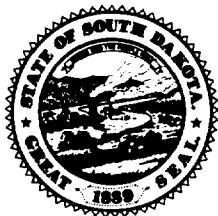

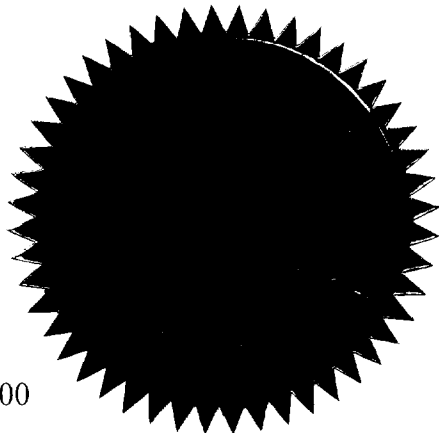

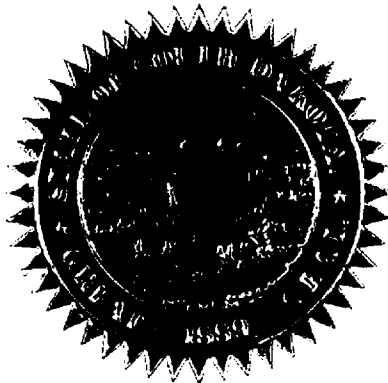

Pursuant to S.D.C.L. § 47-2-9, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is AGS, Inc
2. The following Amendment of the Articles of Incorporation was adopted by the shareholders of the corporation effective March 27, 2002, in the manner prescribed by the South Dakota Corporation Acts:

Article I of the Articles of Incorporation is hereby amended to read as follows:

The name of the corporation shall be Austad's Golf, Inc.

3. The number of shares of the corporation outstanding at the time of such amendment was 139,082 and the number of shares entitled to vote thereon was 139,082.
4. There were no shares of the corporation entitled to vote as a class.

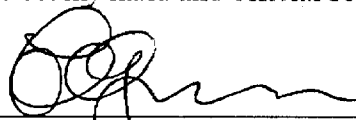

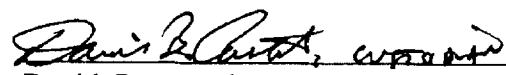

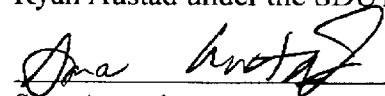
