THIS AGREEMENT, effective on the last day of execution below, by and between KLA-Tencor Corporation, a corporation existing under the laws of the State of Delaware, having an address at 160 Rio Robles, San Jose, California 95134 (hereinafter "KLA-Tencor") and KLA-Tencor Technologies Corporation, a corporation existing under the laws of California and having an address at One Technology Drive, Milpitas, California 95035 (hereinafter "KTT").

WHEREAS, KLA-Tencor is the owner of the trademark applications and registrations shown on Schedule 1 attached hereto ("Trademarks"); and


WHEREAS, KTT is desirous of acquiring said Trademarks and KLA-Tencor is willing to assign the Trademarks;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Parties agree as follows:


