
PARTIES

- (1) **DAVID CAMPBELL PUBLISHERS LIMITED** (registered in England with number 02408013) whose registered address is 22 Melton Street, London NW1 2BW (**Assignor**); and
- (2) **RANDOM HOUSE INC**, a New York company trading through its Alfred A Knopf division of 299 Park Avenue, New York, 10171 USA (**Assignee**).

1. The Assignor is the proprietor of US trade mark number 1525603 and of US trade mark number 1973816 (**Trade Marks**).
2. Under the terms of this agreement the Assignor has agreed to assign all its rights, title and interest in or to the Trade Marks for the consideration set out in clause 3.
3. In consideration of the sum of £1 paid by the Assignee to the Assignor, receipt of which is acknowledged by the Assignor, the Assignor agrees to:
 - 3.1 assign with full title guarantee to the Assignee absolutely all property, rights, title and interest to the Trade Marks including any common law rights and all the goodwill attaching to the Trade Marks, the right to bring proceedings against any third party in respect of the Trade Marks including proceedings against any third party or any infringement of the Trade Marks or for any other passing off which may have occurred prior to the date of this agreement; and
 - 3.2 execute, at the request and expense of the Assignee, all documents, forms, authorisations and depose to or swear any declaration or oath as may be required to vest absolutely full rights, title and interest in the Trade Marks to the Assignee and to record this assignment in the records of any applicable register and/or office.


4. This agreement is to be governed by and construed in accordance with English Law and the parties agree to submit to the non-exclusive jurisdiction of the English Courts.
