

The Assignor shall undertake, at the request of the Assignee, to sign all documentation, including confirmatory trademark and domain name assignments and conveyances, and generally use reasonable best efforts to aid the Assignee, its successors, assigns and nominees, in obtaining all rights from the Assignor and in recording title to the Marks transferred herein in each jurisdiction where such Marks are used or are registered or where applications to register such Marks are pending.


