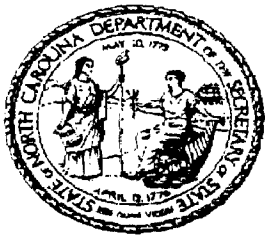

Limited Liability Company
(Conversion of Business Entity)**

Pursuant to §57C-2-21 and §57C-9A-03 of the General Statutes of North Carolina, the undersigned does hereby submit these Articles of Organization for the purpose of forming a limited liability company under the laws of the State of North Carolina pursuant to a conversion of another business entity:

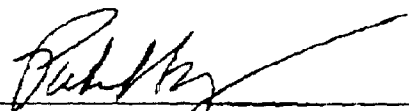
