**GRANT OF SECURITY INTEREST  
IN TRADEMARKS**

**FOR GOOD AND VALUABLE CONSIDERATION**, receipt and sufficiency of which are hereby acknowledged, Orange County Transportation Authority, a public agency organized under the laws of the State of California (the "Grantor") with principal offices at 550 South Main Street, Orange, California. 92868 hereby assigns and grants to Wachovia Bank, National Association, formerly known as First Union National Bank, as Trustee, with principal offices at 5847 San Felipe, Suite 1050, Houston, Texas 77057 (the "Grantee"), a security interest in (i) all of the Grantor's right, title and interest in and to the United States trademarks, trademark registrations and trademark applications (except for intent to use applications for trademark registrations filed pursuant to Section 1(b) of the Lanham Act unless and until an Amendment to Allege Use or a Statement of Use under Sections 1(c) and 1(d) of the Lanham Act has been filed) (the "Marks") set forth on Schedule A attached hereto, (ii) all proceeds and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same.

**THIS GRANT** is made to secure the satisfactory performance and payment of all the Secured Claims of the Grantor, as such term is defined in the Security Agreement, Pledge and Assignment, dated as of July 25, 2001, between California Private Transportation Authority, L.P., CPTC LLC and the Grantee, as amended by Amendment No. 1 to Security Agreement, Pledge and Assignment, dated as of January 3, 2003, between the Grantor and the Grantee (as amended from time to time, the "Security Agreement"). Upon the payment in full of the Secured Claims, the Grantee shall execute, acknowledge, and deliver to the Grantor an instrument in writing releasing the security interest in the Secured Claims acquired under this Grant.

This Grant has been granted in conjunction with the security interest granted to the Grantee under the Security Agreement. The rights and remedies of the Grantee with respect to the security interest granted herein are as set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.

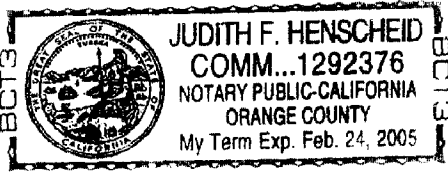

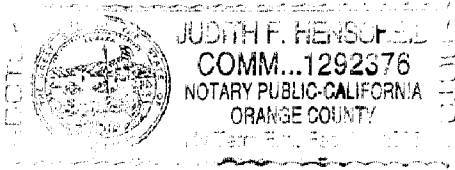

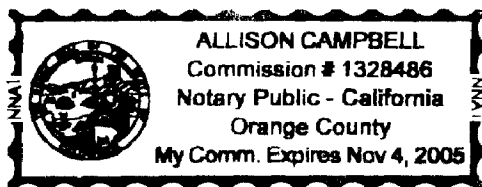
